The European Air Law Association has been established in order to promote the study of the law and institutions of the European Community in relation to air transport and the development of a common air transport policy. This is the Inaugural Conference of the Association. It will be followed by regular conferences held in various Member States of the European Community.

The application of the Treaty of Rome to the air transport sector has, in recent years, undergone dramatic changes marked by the recent judgments of the Court of Justice in *Nouvelles Frontières* and *Ahmed Saeed*, the measures adopted by the Council on 14 December 1987 and those proposed for adoption by 30 June 1990. The liberalisation of civil aviation is giving rise to many significant issues and is playing an increasingly important role in the completion of the internal market.

The speakers at this conference will evaluate the applicability of Community law to air transport and what is likely to happen over the next few years. There will be opportunities for discussion.
