Recent Developments in EC Air Transport Law and Policy

15 November in Berlin

In the period since the Association's last conference in November 1990, EC legislation and policy in the air transport sector has gained further momentum. This is due to the approaching deadline for the completion of the internal market on the one hand and the opening of Eastern European countries on the other. The purpose of this year's annual conference is to discuss the recent developments in two major areas of concern for the industry. First, the conference will examine the impact of EC competition law on the air transport sector in the area of slots, merger control and state aids. The second part of the conference will focus on the relationship between the European Community and third countries, in particular the United States, and on the problems arising under the GATT.
