- The second panel will deal with aviation litigation strategies, particularly from a jurisdictional point of view, which is of great significance currently in the Germanwings case. The pros and cons of arbitration being used for the resolution of policy disputes will be examined as well as the admissibility of technical aviation accident reports as evidence.
- The third panel will take a closer look at significant airport and ground handling developments: The recent German decision regarding the non-enforceability of the limitation of liability under the IATA Standard Ground Handling Agreement, the system used at Japanese airports to determine and allocate liability for damage to property on the ground caused by objects fallen from aircraft and liability issues involving airports in the Middle East including the U.S. electronics ban for Middle East flights.
- Best practices in handling aviation insurance claims.
- The final panel concluding the 11th Munich Liability Seminar will deal with current developments concerning the very dynamic sector of drones. The speakers will address liability and insurance as well as regulatory and enforcement issues.

We invite all aviation lawyers, airline, insurance and reinsurance industry, aircraft finance, airport and aerospace industry representatives as well as government officials and academics to join us for this comprehensive programme.

The one-day format and the timing of the very successful ten liability seminars to date have been retained in order to allow the delegates to travel to and from Munich the same day from most places in Europe.
