EUROPEAN AIR LAW ASSOCIATION (EALA) 28TH ANNUAL CONFERENCE

EALA is delighted to invite you to attend its 28th annual conference, to be held in the charming and historic city of Warsaw, which has gone through periods of intensive changes but whose population has shown a remarkable resilience. Historically, Poland has strong bonds with aviation; as early as 1790 Jan Potocki became the first Pole to fly in a balloon over Warsaw. Many other Poles built, and successfully and bravely flew, gliders in the late nineteenth century. LOT, Poland's first national passenger airline, was established in 1929, and thus belongs to the oldest, still operating airlines in the world. Poland had an aircraft industry manufacturing more than 4,000 airplanes and over a thousand gliders up to 1939 but it vanished in the years after.

EALA'S MISSION

Since 1989, EALA has arranged conferences and seminars in Europe focusing on important legal issues regarding the aviation industry. Over those 27 years EALA has gained international recognition and respect as a leading forum for the discussion of topical developments regarding aviation law, especially from a European perspective. The mission of EALA is, among other things, to:

- serve as the leading and essential association addressing the development of air law in Europe;
- ensure dissemination of information about, and the study of, air law in Europe, and
- be a forum for the exchange of views and provide an opportunity for those interested in European air law to meet each other.

EALA'S 28TH ANNUAL CONFERENCE

Exactly thirty years ago, the European Court of Justice made its landmark decision in a competition case involving the French travel agent *Nouvelles Frontières*. The name was portentous for European air law, as this decision opened borders by bringing together international air transport law and European competition law. In those days, the two could not be combined in a natural or logical way as they were based on different and sometimes opposing concepts. However, in the ten years that followed, airlines, especially the so called flag carriers, had to adjust to new market conditions, and they did.

The opening session will touch upon these developments, and also feature keynote addresses from distinguished Polish speakers. These will be followed by brief presentations on two topical subjects – Brexit and the EASA basic regulation.

After that, the first session will address accident investigation, which keeps on raising legal questions pertaining to the relationship between the safety investigation and the examination of the case by public prosecutors. The two have to comply with regulatory requirements from an international and domestic law point of view, while European law attempts to harmonise the two levels. Procedures can be complex, and the issue of human factors as a cause of these accidents a sensitive one. Accidents may also give rise to international repercussions.

When information is disseminated digitally, it is stored, and wanders inside virtual clouds, but who is controlling those

intangible movements? That question also affects passengers using air services, as the data they transmit to airlines may be kept because they are employed to enhance aviation security. However, they may be accessed by third parties in this open, not always protected cyberspace. Thus, privacy rights of individuals may have to be balanced against, among others, security concerns. The second session will examine the latest developments in this field.

Passenger rights keep us busy again, as they must be constantly reviewed in the light of new decisions made by the Court of Justice of the EU and other courts. The Commission has also recently published guidelines for the interpretation of Regulation 261. Tensions between domestic regulations and international law have yet again to be bridged without compromising the relationship between the airline and its principal customer, namely, the passenger.

2016 will hopefully become the year in which global understanding will be reached on the establishment of Global Market Based Measures designed to protect the environment by the stabilisation and, where possible, reduction of emissions made by aircraft. Europe plays a principal role in this process, because it led the way by establishing its Emissions Trading Scheme whose application is now restricted to flights within the European Economic Area. However, should the Assembly of ICAO not reach a – worldwide – consensus on this subject in October 2016, the EU has announced that it will revive the application of this regime to also include international flights from and to the EU. From that perspective, our conference could not be more timely, as here again domestic policies and regulations will be tested against an international benchmark.

Appropriately, in view of the anniversary of the *Nouvelles Frontières* judgement, the final panel will deal with competition law. In early 2016, the Court of Justice of the EU issued a notable decision on the appeals in the cargo cartel cases, annulling the Commission's decisions, which imposed substantial fines against a number of airlines. This decision has implications which can only be understood if explained by experts in this field. This is also true for the most recent case law on State aid involving airlines and airports.

Traditionally, the conference will be concluded by the grant of the EALA's prizes for the two best papers which have been written by students from all over the world in the past year. After that, we shall raise a glass to what has hopefully been a successful and inspiring conference.
